MOST FILIPINOS BACK PH'S RETURN TO ICC - SURVEY

MANILA - The results of an Octa Research survey showed that more than half, or 57 percent, of Filipinos are in favor of the Philippines rejoining the International Criminal Court (ICC).

The Tugon ng Masa survey, conducted from April 22 to 24, showed 37 percent opposed the idea while 6 percent were undecided.

The majority or 60 percent of the respondents in Metro Manila, Luzon, and the Visayas support the move.

The strongest opposition was seen in Mindanao, with 66 percent of the respondents rejecting the idea and only 30 percent in favor.

High awareness of the ICC was seen among adult respondents, with 85 percent saying they had heard or read about the court.

The survey also indicated that about half of the respondents from all socioeconomic classes and age brackets showed support for the country's return to

P9.4B worth of seized drugs completely destroyed

No trace of illegal drugs was found in the final residue of narcotics destroyed during a high-profile thermal destruction event led by President Ferdinand R. Marcos Jr., with authorities confirming that all four ash samples tested negative for shabu, marijuana, cocaine, and ecstasy.

In a report submitted by the Philippine Drug Enforcement Agency (PDEA), the ashes retrieved from the thermal facility in Capas, Tarlac were tested to ensure accountability and scientific validation in drug disposal. The report was backed up by three photos of the actual testing.

The four bottles of ashes were collected from separate burn batches, each subjected to chemical analysis to detect any remaining traces of narcotics. All tests came back negative, confirming the thoroughness of the incineration process.

The event marks the culmination of a multi-agency effort to destroy PhP9.4 billion worth of illegal drugs, including a massive cache of methamphetamine hydrochloride or shabu recovered recently by fishermen off the coast of northern Luzon.

On Wednesday, President Marcos witnessed

the chemical testing of random samples of the total 1,530.647 kilos of shabu, marijuana, cocaine, and ecstasy before their destruction at the Clean Leaf International Corp., a waste management company in Capas, Tarlac.

The President has advocated a "balanced, humane, and evidence-based" approach to the anti-drug campaign to emphasize the importance of public trust in the government's enforcement efforts.

The ash testing is considered a key safeguard in the destruction

protocol and a strong countermeasure against allegations of drug recycling, a shift in policy that emphasizes the rule of law, inter-agency collaboration, and community involvement.

At the same time, the ashes would be disposed of following environmental regulations, concluding a comprehensive process that began with interdiction and ended with validated de-



struction.

The "floating shabu" haul worth PhP8.87 billion, one of the largest drug seizures in the country's history, was credited to the vigilance of local fishermen and the swift response of maritime authorities — a testament, the President said, to the power of cooperation between government and civil society. (PND)

PGH's new specialty center, symbol of quality public healthcare - Palace

The Philippine General Hospital (PGH) has officially commenced construction on its 16-story pediatric and adult specialty center, flagship project aligned with President Ferdinand R. In a Palace press

briefing on Friday, Presidential Communications Undersecretary and Press Officer Claire Castro highlighted the significance of the project, noting that it is a testament to the Marcos administration's dedication to quality public healthcare for all Filipinos.

PAGCOR WARNS PUBLIC VS. ILLEGAL OFFSHORE GAMING SITES

MANILA – President Ferdinand R. Marcos Ir. has designated former Philippine Basketball Association (PBA) chairperson Patrick Gregorio as the new head of the Philippine Sports Commission (PSC), Malacañang announced on Saturday.

Executive Secretary Lucas Bersamin confirmed in a text message that Gregorio will be replacing Richard Bachmann, a former PBA player who was appointed to the top PSC post in December 2022.

Bersamin did not divulge as to when Gregorio, currently president of the Philippine Rowing Association, would assume his new

Malacañang did not release a copy of Gregorio's appointment paper.

Gregorio also served as executive director of the Basketball Association of the Philippines (now Samahang Basketbol ng Pilipinas) and governor of Talk 'N Text in the PBA, where he was chair in the 40th season (2014-2015).

On the corporate side, he is head of Landco Lifestyle Ventures, which oversees the operations of Camp John Hay legacy hotels. (PNA)

PTFOMS Hails Court's Acquittal of Bacolod Journalist in Libel Case

The Presidential Task Force on Media Security (PTFOMS) applauds the Bacolod City Regional Trial Court Branch 53's decision to acquit journalist Erwin "Ambo" Delilan, formerly of SunStar-Bacolod, after nearly two decades of legal proceed-

The court determined the prosecution failed to prove libel charges beyond a reasonable doubt, charges that arose in 2005. Delilan's reporting on a dispute cited official complaints without additional commentary or malicious intent. This action was deemed to be within the realm of responsible journalism and protected by the constitutional freedom of the press.

"This ruling underscores a fundamental tenet of press freedom: journalists should not be penalized for reporting matters of public interest in good faith and without actual malice," said Undersecretary Jose Torres Jr., executive director of PTFOMS. "The law clearly demands a higher standard of proof in libel cases involving public figures."

"Mr. Delilan's acquittal is a personal victory and a reaffirmation of the vital role the press plays in a democratic society," said Torres. "We commend the court's decision and reiterate our strong commitment to safeguarding journalists from harassment, intimidation, and prolonged legal battles meant to stifle critical reporting."

PTFOMS is committed to institutionalizing rerms to prevent the misuse of libel laws against the media and stands ready to support media practitioners in their pursuit of safe, ethical, and fearless journalism. Earlier this week, PTFOMS praised the establishment by the Philippine Press Institute of Media-Citizen Councils as "platforms for dialogue, oversight, and mutual understanding."

The Media-Citizen Council is a multi-sectoral, community-based, and independent group that aims to resolve conflicts between and among media and those who complain about inaccuracies in news reports via mediation through Appropriate Dispute Resolution.

It works on the framework of the Philippine Initiative under the Philippine Plan of Action for the Safety of Journalists and on the framework of independent media self/co-regulation, media accountability and safety, ethical and responsible journalism, good journalism as a public good, and strategic engagements with various sectors in the community, including the local government units, government agencies, and law enforcers. PAPI ELECTS ITS NEW BOARD FOR 2025-2028

MANILA, PHILIPPINES — One of the country's largest and oldest media organizations representing the publishing sector, the Publisher's Association of the Philippines Inc. (PAPI), has elected its new set of board members last June 24, 2025, at the National Press Club in Intramuros, Manila.

The newly elected officials are now-President, Rebecca M. Velasquez (former executive vice president), publisher of Pulso ng Makabagong Caviteno; Executive Vice President, Ian Junio, publisher of Hyperland News Publishing; Re-elected Vice President for Luzon, Alma Omilig Ochotorena, publisher of News Syndicate Digest; Vice President for Visayas, Danilo N. Silvestrece (former board of director for Visayas), publisher of Balita Tirador Publication; Vice President for Mindanao, Anila Anne B. Acosta (former board of director for Mindanao), publisher of Mindanao Expose'; Secretary Reyland Lopez, publisher of Unang Milenyo News Publishing Center; Re-elected Treasurer, Leonida Pascua Cardona, publisher of People's Monitor Publication: Auditor, May Ann Reyla, publisher of City View Publishing; Re-elected Board of Director for Luzon, Eduardo Cardona, publisher of Rizal Voice Publication, and Dina Diaz, publisher of Tarlac Insider Weekly Newspaper; Board of Director for Visayas, Giecel Albar, publisher of Akeanon News Publishing Services; and Re-elected Board of Director for Mindanao Elpedio Bermas Soriano Jr., publisher of Eagles Journal and Joseph Denmarc Miranda Avila, publisher of Pervodista Publica-

Held concurrently with its national elections and the mid-year general assembly, bearing the theme 'Fighting Fake News as a United Mission,' National Press Club President Leoniel Abasola, Dr. Lily Lim, and the Presidential Task Force on Media Security (PTFoMS) Undersecretary, Joe Torres Jr. extended their message of support towards the organization, expressing their immense gratitude to PAPI for their enduring partnership over the years.

In his speech, Torres ensured that the status of the late-Chairman Emeritus of PAPI, Juan "Johnny" P. Dayang Sr., is taken into careful investigation to obtain justice in its right order. Dayang was shot and killed in the evening of April 29 by now-identified gunmen at his house in Kalibo, Aklan, where he served as its former officer-in-charge mayor after the 1986 Philippine Revolution.

Additionally, veteran broadcast journalist and re-appointed Secretary of the Presidential Communication Office (PCO), Jay Ruiz, showed his full support to the outgoing President, Nelson Santos, and PAPI by attending the event and delivered a speech that empowered wise and critical decisions among the publishers in the age of digital media and the need to forge a collaborative effort in fighting relentlessly with fake news, hence imposing penalties to fake news peddlers.

"Kailangan tayo magkaisa, labanan natin itong fake news, at i-impose na dapat sila rin magbayad ng buwis, magkaroon [ng] kahit na papaano regulasyon o pananagutan kung yung plataporma mo ay nagagamit sa fake news," Ruiz mentioned.

"Maganda po yung relationship ng PAPI at ng PCO, at 'yan po ay magpapatuloy habang nandito po kami. Tiyak po 'yan. Kasi nais naming ipa-abot sa mamama-

yang Pilipino – hindi lang dito sa Metro Manila, kundi sa buong Pilipinas na ang gobyernong Marcos ay para sa tao. Magtulungan po tayong ipa-abot ang mga programa, aktibidades, at mga polisiya ng gobyerno," he added.

Hence, alongside the assembly and elections, PAPI then paid tribute to the 90th birthday of Dayang where his son, Consul General to Turkey Juan "Jed" Dayang Jr., expressed his heartfelt thanks to the organization through a video message emphasizing that remembering is not enough – if his father were truly honored, shall the memories, contributions, and the legacy left by his father, not only with the organization, but also all over the country that had

helped flourish the press freedom, must be carried forward.

"He believed that journalism was never about comfort, it is about courage. So I ask of you now, let's not reduce his death to a headline, let's not treat this tribute as a farewell – let it be a signal, a challenge, a commitment to speak when it is dangerous, to write when it is unpopular, to never trade truth for access, or silence for safety," Dayang said.

In high hopes for the new board members, Jed Dayang also mentioned in his video to continue fighting for press freedom, and moving forward, as their family will always be there to support the organization, just like what his father used to do.

The newly elected officials are set to take office after their oath-taking, which is yet to be announced by the new board, and will serve until 2028. (Binsoy Velasquez)

PBBM SWEARS IN NEW CUSTOMS CHIEF



President Ferdinand R. Marcos Jr. has sworn in Ariel F. Nepomuceno as the new Commissioner of the Bureau of Customs (BOC), the government agency tasked to intensify efforts to combat smuggling and illicit trade.

Before his appointment, Nepomuceno served as executive director of the National Disaster Risk Reduction and Management Council and undersecretary of the Office of Civil Defense.

As the country's principal border protection and trade facilitation agency under the Department of Finance, the BOC plays a vital role in generating revenue, ensuring national security, and promoting economic stability.

While initially established to collect duties and taxes, the bureau has evolved into a critical institution dedicated to combating illegal trade, promoting legitimate commerce, and enhancing border control.

President Marcos' marching or-

der for the BOC is to safeguard the country's borders and ensure transparency and efficiency in revenue collection.

Nepomuceno is not new to the BOC, as he had previously held positions within the agency, including assistant commissioner of the Post Clearance Audit Group from December 2017 to April 2018 and deputy commissioner of the Enforcement Group from December 2013 to February 2017.

He also served as director and CEO of the Office of Civil Defense under the Department of National Defense from December 2012 to March 2013, and as a consultant at the Office of the President in 2003.

In the early 2000s, he held executive positions at Food Terminal Inc. and Avalon Pacific Corporation, where he started his career as vice president for operations in 1997.

Most recently, since 2019, Nepomuceno served as chairman and CEO of Malayan Pacific Power Holdings Corporation. **(PND)**

Ezekiel 37:7-10

Then weakness reveals man's futility, we often try to resolve it on our own. Only when we're pinned in a corner do we cry out to God. While it is good to come to Him, running to Him as a last resort reveals a lack of understanding of the power of His Word.

In our passage, the prophet Ezekiel was given a vision—an image of bones in a valley, symbolizing Israel's condition. Their nation was conquered, their king defeated, blinded, and left to die in Babylon. Many of their countrymen had been slaughtered. Israel was bone dry with hopelessness.

God asked Ezekiel, "Can these bones live?" His answer showed that he recognized God as the resurrection and the life. Then God explained what would happen—and it began with His Word.

Verse 7 uses "behold" twice to draw special attention to what is happening—where the Word of God begins its work to bring life. This proves that God's Word cannot contradict His work because God has all knowledge and all power to fulfill His Word through His actions. God does not doubt, nor does He change His words.

When God created everything, He spoke and it came to be. He did not collect things to make things, but He decreed and it was. God is also recreating the heart of those dead so that they will believe.

Verse 7 uses "behold" twice to draw special attention to what is happening—where the Word of God begins its work to bring life. This proves that God's Word cannot contradict His work because God has all knowledge and all power to fulfill His Word through His actions. God does not doubt, nor does He change His words.

God's Word is like the sun to the earth. Without it, the earth would be cold and lifeless chaos. The sun gives light, warmth and order—just as God's Word gives clarity, meaning, and sustains all things. Without it, life would be like wandering in a cold, dark void—nothing would grow, nothing would make sense, and everything would fall apart.

Ask yourself: Do you begin your day in the Word of God? Or do you wait for God's work without valuing His Word? Depend on the Word of God, and recognize its importance to give true life —even to someone who seems to be alive on the outside. Make it your daily breath.

OVER 30K MAKATI ELDERLY, PWDS RECEIVE FREE MULTIVITAMINS, MAINTENANCE MEDS

QUEZON CITY, (PIA)—The Makati City government is providing free multivitamins and maintenance medications to over 30,000 senior citizens and persons with disabilities.

Outgoing Mayor Abby Binay said over the weekend that the expanded medical service program would benefit 15,149 senior citizens aged 60-69 and 15,748 registered persons with disabilities.

"They will receive full doses of essential medications through Planet Drugstores at health centers, Ospital ng Makati, and Makati Life Medical Center," she said.

Previously, only senior citizens 70 and older were entitled to receive full doses of maintenance medications. The rest of the beneficiaries, including those under 70, persons with disabilities, and city government employees. received half a month's supply.

Binay said the enhanced program is a major step forward in her administration's commitment to providing accessible healthcare to vulnerable residents.

During her nine-year term, Ospital ng Makati reported nearly 5 million free healthcare interactions delivered to almost 2 million patients.

The initiative builds on Makati's established healthcare infrastructure, including Ospital ng Makati's 92% recovery rate and comprehensive services that have treated nearly 2 million patients.

Makati's healthcare programs have delivered life-saving services to thousands, including 32,951 patients who received dialysis treatment through the Unli Dialysis program and 11.364 cancer patients who received treatment through the subsidized Ambulatory Chemotherapy Program. (JEG/PIA-NCR)

PAG-IBIG OFFERS 4PH HOUSING TO CIVIL SERVANTS

QUEZON CITY, (PIA)—The Philippine Information Agency hosted a program on Monday, where Pag-IBIG Fund officials shared updates on their housing projects, including the 4PH (Pambansang Pabahay Para sa Pilipino) Program.

Pag-IBIG Fund's Institutional Housing Department Chief Engr. Enrique Consuelo discussed the 4PH Program, a government flagship housing project aimed at providing affordable homes to Filipino workers, particularly low-income and informal sector workers.

Consuelo said that to be eligible for the 4PH, individuals must be "Pag-IBIG members with at least 24 months of contributions, have no existing housing loan or foreclosed Pag-IBIG property, and have the capacity to pay."

"Priority may be given to government employees, overseas Filipino workers, and vulnerable sectors," he said.

Consuelo encouraged government employees to participate in "group bidding," a process where multiple entities collaborate to submit a project proposal for the 4PH Program.



This can be done regionally or across the entire country.

The 4PH Program is a significant step towards providing safe, decent, and affordable homes for all Filipinos. Consuelo emphasized the lasting benefits of owning a home with government assistance.

MIXED RESULTS MARK TREASURY BILLS AUCTION

MANILA – Results were mixed during the Treasury bills (T-bills) auction on Monday as the Auction Committee decided to fully award bids for the 180-and 364-day T-bills while partially awarding the 91-day security.

Average rates for the 180and 364-day T-bills fell below prevailing secondary market rates, settling at 5.607 percent and 5.651 percent, respectively.

The 91-day security, meanwhile, was capped at an average of 5.526 percent.

Last week, the average rate of the 91-, 182-, and 364-day T-bills settled at 5.530 percent, 5.557 percent, and 5.655 percent, respectively.

"The Treasury bill average auction yields were most-

ly corrected marginally lower by -0.004 for the 91-day and 364-day tenors, except for the +0.05 weekly rise in the 182day tenor, after global crude oil prices declined to the lowest in more than 2 weeks and erased all of the world oil price increase since the Israel-Iran conflict started amid the tentative ceasefire between the two countries as announced by Trump," Rizal Commercial Banking Corporation chief economist Michael Ricafort said.

The auction was 2.3 times oversubscribed, with total tenders reaching PHP57.7 billion.

With its decision, the Committee was able to raise PHP24 billion out of the PHP25 billion planned offering. **(PNA)**
