TOURISTS TOLD TO PRIORITIZE SAFETY AMID BAD WEATHER

MANILA - The Department of Tourism (DOT) on Monday advised tourists and tourism stakeholders to remain vigilant and prioritize safety in their travel plans, given the heavy rainfall currently being experienced in areas of Luzon and the Visavas.

In an advisory, the DOT urged travelers to check with airlines, ferry operators, and other transport providers regarding the status of scheduled trips before proceeding with their trips.

Tourism-related establishments have also been enjoined to provide timely updates and support services to their guests, especially those affected by the storm's impact.

The DOT issued the advisory following the adverse effects of Tropical Storm Crising (international name: Wipha) and amid the rains brought travel, flooding, and landslides, particularly in elby the southwest monsoon or "habagat."

The DOT encouraged tourists and stakeholders to closely monitor weather bulletins and travel advisories from relevant authorities.

According to the Philippine Atmospheric, Geophysical and Astronomical Services Administration (PAGASA), widespread moderate to heavy rainfall is expected to persist over Metro Manila, Central Luzon, Calabarzon, Mimaropa, Ilof the Visavas.

These conditions may lead to dangerous sea tropical storm. (PNA)

The DOT said its Disaster Risk Reduction and Management Committee is on heightened alert and is actively coordinating with local government units and tourism offices to monitor developments on the ground and extend assistance where needed.





This visit highlights DA-BAR's continuing efforts to strengthen the link between science and agriculture through research and development, aiming to further improve the sector and promote local products in broader markets.

Week in Review: PBBM focuses on fast-tracking big-ticket infra projects

President Ferdinand R. Marcos Jr. is working hard to improve the lives of Filipinos by leading and closely overseeing key government initiatives, from infrastructure and transportation to energy, housing, and digital services.

President Marcos' hands-on approach ensures that these efforts do not merely symbolize improvement but translate into tangible improvements for communities across the country.



Following a visit to the Caticlan airport, President Marcos flew over the Malampaya oil and gas platform aboard a helicopter, conducting an aerial inspection of the drilling operations off the coast of Palawan. Malampaya Phase 4 (MP4) involves drilling three new deep-water wells to deliver a new gas supply by 2026.

On July 16, President Marcos led the launching of the Department of Transportation's (DOTr) 50 percent discount for senior citizens and persons with disability (PWDs) using LRT-1, LRT-2, and MRT-3. The hefty discount took effect on the same day.

The President led the first batch of senior citizens on the inaugural trip of the so-called Dalian trains at the Santolan-Annapolis MRT station, expressing satisfaction that the Dalian trains had finally been put into service.

From the inaugural trip, President Marcos proceeded to inspect the portion of the Metro Manila Subway project at the Camp Aguinaldo Station. While the entire subway would span


from Valenzuela City to the Ninoy Aquino International Airport in Pasay City, the President hoped the Valenzuela to Camp Aguinaldo segment could be completed by 2028.

Meanwhile, in line with President Marcos' mass housing program, Malacañang said around 5,000 informal settlers are slated to own lots through the 34 revived on-site housing projects across key areas in Luzon and Visayas.

The Department of Human Settlements and Urban Development (DHSUD) approved the proposal of the Social Housing Finance Corporation (SHFC) to revive the Community Mortgage Program (CMP) in 34 sites initially in Luzon and the Visayas.

On July 18, President Ferdinand R. Marcos Jr. launched the Bagong Pilipinas eGovPH Serbisyo Hub and the eGovPH Super App, key components of his administration's push for digital transformation in public service.

Unveiled in Pinaglabanan, San Juan, the Bagong Pilipinas eGovPH Serbisyo Hub (BPESH) serves as a one-stop shop that integrates the services of around 70 government agencies, streamlining the delivery of essential public assistance and making government transactions more accessible, efficient, and citizen-friendly. PBBM ENCOURAGES FILIPINOS TO USE AI

President Ferdinand R. Marcos Jr. on Sunday urged Filipinos to harness artificial intelligence (AI) as a learning tool, emphasizing that regular use improves its ability to deliver helpful responses.

"Ang AI, natututo. Mas lalo mong gagamitin, mas lalong gagaling ang sagot sayo. Kaya't gamitin ninyo nang gamitin, para iyong AI masanay sa inyo. Pagkatagal nang panahon makikita ninyo, iyong sagot ng AI sa mga tanong niyo ay paganda nang paganda," President Marcos said in his latest video blog, posted on Sunday.

The Chief Executive enumerated some practical uses of AI that Filipinos can start with, such as asking for directions, inquiring about activities at a particular place, and seeking assistance with writing speeches.

In the vlog, an AI-generated segment show-casing Filipino creativity featured the President pausing his vlog in a Malacañang office, rising from his seat, donning a black leather jacket, and dramatically spinning with arms outstretched. The office walls then collapsed, revealing a stage set for what appeared to be a rock concert.

Amid the productive uses of Al, President

Marcos lamented that some people are also using the technology nefariously and warned against such misuse.

"Sa kabila ng magagandang development na ito, nakakalungkot na ginagamit din ito ng masasamang-loob sa mga scams, sa mga fake news, sa pagpapalaganap ng maling impormasyon. At marami sa atin ang nabibiktima dito," the President said.

Encouraging the use of AI has been part of the Marcos administration's push for digitalization, alongside enhancing internet connectivity across the archipelago and offering government services online via smart apps.

Last May, the government unveiled "TunAI," an AI-powered app embedded within a social media platform that can detect fake news, verify facts, and direct users to legitimate sources.

The Department of Information and Communications Technology has announced the development and training of the country's own AI engine, designed to assist Filipinos in activities such as gathering information and reporting crimes, and capable of responding in dialects familiar to users. (PND)

NO MORE LINES, NO MORE FIXERS: EGOV PH REVOLUTIONIZES PUBLIC SERVICE DELIVERY FOR FILIPINOS



True to his promise to address Filipinos' daily needs, President Ferdinand R. Marcos Jr. on Friday introduced the Bagong Pilipinas eGov PH Super App and eGov PH Serbisyo Hub, marking a major milestone in the government's push to modernize and simplify public service delivery.

In his speech at the Makabagong San Juan National Government Center, the President said the new digital platform and physical hub aim to make government transactions faster, more convenient, and corruption-free.

"Walang pila. Walang fixer. Walang korapsyon. Iyan ang makukuha natin dahil sa eGov app at one-stop shop na ating binuksan ngayon," President Marcos said, emphasizing his vision for a responsive and citizen-friendly bureaucracy.

The administration launched the initiative to address common pain points in accessing government services—such as long lines, fixers, and bureaucratic red tape—by integrating multiple national agency functions under one roof and into a single app.

The Chief Executive highlighted that many Filipinos lose valuable time and income trying to secure basic documents, only to be told to come back another day due to incomplete requirements.

"Pupunta ka sa isang opisina. Pipila ka ng dalawang oras... pagkatapos, sasabihan ka pa na kulang ang requirements. Kailangang bumalik. That is impossible for an ordinary citizen," President Marcos said.

"That's why we have always aspired to a real one-stop shop. Ngayon, ito na 'yon. At hindi lang sa San Juan — isusunod na ito sa buong Pilipinas," he added.

The eGov PH Super App, developed by the Department of Information and Communications Technology (DICT), integrates various government services into a single digital platform accessible via smartphone, tablet, or desktop.

Citizens can file applications, track requests, verify their identity, and eventually make online payments, all without leaving their homes.

"Basta't may connectivity, hindi na kailangang pumunta sa poblacion o sa opisina ng ahensiya. You can do all of this online — nasa bahay ka lang," the President said.

President Marcos added that more than 88 million Filipinos now have a digital national ID, which links seamlessly with the app. The rollout of physical IDs will follow to accommodate sectors that prefer printed versions.

To support those with limited internet access, President Marcos announced that the government will roll out eGov PH Serbisyo Hubs in other local government units (LGUs), providing walk-in access to essential national services in a single convenient location.

President Marcos urged all agencies to help spread awareness and encourage adoption of the app, noting that even first-time users will find it easy to navigate. **(PND)**

BI nabs Chinese man linked to drugs and human trafficking



GEN. TRIAS, CAVITE—Agents of the Bureau of Immigration (BI) Fugitive Search Unit (FSU) arrested a Chinese national linked to illegal drug activities and human trafficking of women.

According to a report from BI FSU Chief Rendel Ryan Sy, the operation, which was conducted in coordination with the Philippine Drug Enforcement Agency (PDEA) and the Philippine Navy, led to the rescue of two women allegedly being held against their will by the suspect.

The Chinese man, identified as Jin Tian, 26, was arrested in his residence in General Trias, Cavite on July 15

During the operation, authorities also encountered two additional male Chinese nationals—Sun Yong, 36 and Liu Zhiwei, 33. Sun was found by PDEA operatives to be in possession of a substance believed to be methamphetamine and associated drug paraphernalia.

All three individuals were found to be overstaying aliens and failed to present valid immigration documentation. Further verification showed that Jin has two active derogatory records stemming from an immigration case for overstaying.

Jin and Liu will be transferred to the BI Warden Facility, while Sun will remain in the custody of PDEA for prosecution of his drug-related case.

"This operation reflects the government's unwavering commitment to protecting our communities from criminal activity perpetrated by illegal aliens," said BI Commissioner Joel Anthony Viado.

"Under the directive of President Ferdinand R. Marcos Jr., the BI continues to intensify efforts to identify and remove foreign nationals who abuse our hospitality and violate our laws. We are equally committed to ensuring that vulnerable individuals—especially women—are rescued and protected," he added.

Viado further commended the inter-agency coordination, saying, "We thank our partners for their support and vigilance. Together, we send a clear message: the Philippines is not a haven for fugitives, traffickers, or those involved in illicit activity."

The rescued women are currently being evaluated and assisted by proper authorities. (BI)

PAGCOR ORDERS TAKEDOWN OF GAMBLING BILLBOARDS

The Philippine Amusement and Gaming Corporation (PAGCOR) has ordered the immediate dismantling of all billboards and out-of-home (OOH) gambling advertisements in its intensified efforts to regulate gambling-related promotions in public spaces.

In a memorandum issued on July 7, PAGCOR directed all licensees, suppliers, system administrators, and gaming venue operators to take down gambling ad materials, including those displayed on trains, buses, jeepneys, and taxis.

The agency emphasized that only institutional or responsible gaming campaigns—subject to PAGCOR's approval—will be permitted moving forward.

"We have given all our licensees and stakeholders until August 15 to completely remove all gambling-related ads," said PAGCOR Chairman and CEO Alejandro H. Tengco.

"Prior to that, stakeholders must also submit an inventory of their existing billboard and wallscape advertisements by July 16."

The inventory, according to Mr. Tengco, must include the size, material, location, rental contract expiration, and the corresponding permit number from the Ad Standards Council (ASC).

The PAGCOR chief said the move is part of the state gaming agency's commitment to promote a safer and more responsible gaming environment in the country

"While PAGCOR is mandated to regulate the gaming industry and generate revenues for nation-building, we do not want to encourage a culture of gambling addiction," he said.

"Regulating excessive and pervasive gambling advertisements is a critical step in protecting vulnerable sectors of society, especially the youth."

The agency also warned against replacing the dismantled advertisements with new gambling promotions, stressing that non-compliance will be dealt with accordingly. **(PAGCOR)**

- Ecosystem Restoration: Implementing green infrastructure and restoring natural water systems to absorb excess rainwater.

As we confront the challenges posed by climate change, it is essential to adapt our urban planning strategies to safeguard our communities. The DENR remains committed to working hand-in-hand with local government units and the public to create a future that mitigates flooding risks and enhances overall community resilience. Asst. Secretary Dumlao pointed out.

The DSWD's Buong Bansa Handa (BBH) program, as mentioned by Asst. Secretary Dumlao, has significantly improved the agency's disaster readiness through government and private sector-driven supply chains, enabling rapid augmentation of local government resources, especially in geographically isolated and disadvantaged areas (GIDAs).

"Because of the BBH program, we also have entered into relief prepositioning agreements with various local government units (LGUs) and private organizations so we could use their warehouses para yung mga goods natin ay nandoon na po sa ground, nandun na po sa mga lugar that are potentially to be affected by various hazards," the DSWD-DRMG official said.

Asst. Secretary Dumlao said that with the mechanized packing system in the DSWD's NROC in Pasay and VDRC in Cebu province, the production of FFPs has drastically increased from 5,000-10,000 manually packed boxes to 50,000 daily combined output.

"Kung dati, manual operations lang, ngayon, pwede na po tayong makapag-produce ng 50,000 food packs daily using our mechanized packing systems," Asst. Secretary Dumlao said.

"Mas mabilis ang produksyon, mas mabilis po nating maipapadala ang tulong sa ating mga kababayan," the DSWD spokesperson added.

The DSWD's enhanced warehouse inventory system also ensures traceability and food safety. Each box of FFP has a barcode with a manufacturing date, expiry date, and designated area of destination, this preventing spoilage and ensures proper track-

Despite the continuous release of supplies, Asst. Secretary Dumlao said the DSWD maintains its stockpile at 3 million food

DOLE: PRIVATE EMPLOYERS MAY SUSPEND WORK DURING WEATHER DISTURBANCES

ployment-Bureau of Working Conditions (DOLE-BWC) on Monday reminded business establishments that they may suspend work during weather disturbances and similar occurrences, to ensure the safety and health of employees.

In a social media post, the DOLE-BWC said suspension of work is stated in Labor Advisory No. 17 Series of 2022, 'Suspension of Work in the Private Sector by Reason of Weather Disturbances and Similar Occurrences.'

"Employers in the private sector may, in the exercise of management prerogative and in coordination with the safety and health committee. or safety officer, or any other responsible company officer, suspend work to ensure the safety and health of their employees during weather disturbances and similar occurrences," it said.

At the same time, it also reminded companies about the payment of wages for employees who will or will not report to work.

"If unworked: Employee is not entitled to regular pay, except when there is a favorable company policy, practice, or collective bargaining

MANILA - The Department of Labor and Em- agreement granting payment of wages on the said day or when the employee is allowed to utilize his/her accrued leave credits," the advisory


> "If worked: Employee is entitled to full regular pay provided that he/she has rendered work for not less than six (6) hours.

> If less than six hours of work, the employee shall only be entitled to proportionate amount of regular pay, without prejudice to existing company policy or practice more beneficial to the employee," the DOLE added.

> It noted that employees have no liability in case of failure or refusal to work.

> "Employees who fail or refuse to work by reason of imminent danger resulting from weather disturbances and similar occurrences shall not be subject to any administrative sanction," the DOLE added.

The Palace, meanwhile, approved the suspension of classes in all levels, both public and private, and work in government offices in Metro Manila and nearby provinces due to heavy rains brought by the southwest monsoon. (PNA)





HUNDREDS OF OFWS JOIN LTO DRIVER'S LICENSE RENEWAL CARAVAN IN JAPAN

MANILA – Hundreds of overseas Filipino workers (OFWs) renewed their driver's licenses online during the "Serbisyo (Service) Caravan" in Osaka, Japan, on Sunday.

July 22, 29 and August 5, 2025

In a statement on Monday, Land Transportation Office (LTO) acting Assistant Secretary Greg Pua said the caravan was in line with President Ferdinand R. Marcos Jr.'s directive to shift all government services to digital platforms.

"Tagumpay ang isinagawa nating online driver's license renewal at talagang nakakataba ng puso na hindi lang makita ang mga kababayan na sinusuportahan ang programang ito kundi yung taus-puso nilang pasasalamat na mabilis and komportable na ang driver's license renewal nila (Our online license renewal was a success and we're happy to see Filipinos supporting the program and thankful for the fast and comfortable service)," Pua said.

The online driver's license re-

newal was piloted in Taiwan last year and comes with the option of having their license delivered using accredited courier services.

The entire online license renewal from overseas —from the initial application until the delivery of their driver's license to their foreign address— can take anywhere from three to five days.

The LTO is also eyeing the expansion of the program to other parts of the world, particularly in the Middle East, the United States, and Europe.

The evaluation process included site inspections, interviews with business owners and staff, and a thorough review of the enterprise's


innovation practices, technology adoption, productivity gains, and alignment with Industry 4.0 standards.





Pacquiao comeback vs. Barrios ends in majority draw

Pacquiao fell short of pulling off a stunner in his comeback fight against Mario Barrios, as their WBC welterweight title bout ended in a majority draw on Sunday (Manila time) at the MGM Grand in Las Vegas.

The judges scored the 12-round title clash 115-113 for Barrios, and 114-114 on two scorecards, allowing the 30-year-old American to retain his crown.

It was Pacquiao's first fight since announcing his comeback and his first professional bout since 2021.

Pacquiao, showed glimpses of his vintage form, particularly in the early and middle rounds, where he pressed the action and unleashed flurries that recalled his prime

He started strong in the opening two rounds, landing combinations and staying aggressive.

Barrios, however, settled into a rhythm by the third, relying on crisp jabs and effective counters to slow Pacquiao down.

The Filipino boxing icon picked up the pace

in rounds eight through 10, attacking from all angles and thrilling the crowd with bursts of speed and power.

However, the younger Barrios regained control in the final two rounds, capitalizing on Pacquiao's slowed out-

Despite the draw, Pacquiao, boxing's only eight-division champion, impressed fans with his performance at his age, proving he could still compete at the elite level.

Barrios remains the WBC welterweight champion, but the close decision leaves the door open for a potential rematch.

"I thought I won the fight... Of course, I'd like a rematch. I want to leave a legacy and make the Filipino people proud," Pacquiao said in his post-fight interview.

Barrios also expressed openness to face the boxing hall-offamer again.

"I'll do the rematch. Absolutely. This was huge for boxing. I'd love to do it again," he said.

MANILA - The Samahang Basketbol ng Pilipinas (SBP) has expressed its appreciation to Philippine Sports Commission Chairperson Patrick Gregorio for supporting the Gilas Pilipinas Women competing at the FIBA Women's Asia Cup 2025 in Shenzhen, China.

The PSC chief met with FIBA officials to discuss the Philippines' hosting of the FIBA Women's Asia Cup 2027.

"We appreciate the support from Chairman Gregorio in China. This is his first official trip abroad and the SBP is honored by his presence and his help especially about the hosting of the FIBA Women's Asia Cup 2027," said SBP president Al Panlilio in a press statement Sunday.

"We know of the nationwide impact of basketball in the Philippines. And my hope is that more FIBA events can be held in our country, not just in Manila but in other regions because this will help boost sports tourism and also enhance sports diplomacy. SBP has hosted successful FIBA events in Clark and San Fernando, Pampanga and it will be good to give other regions and provinces that same opportunity as well," Gregorio said.

He also used the time in China to better understand FIBA's eligibility rules as he looks at Filipinos in sports globally.

"We know that there are many athletes all over the world who proudly represent the Philippines even if some of them may have not gotten a Philippine passport yet before they turned 16. Some of them even represent us in the Olympics. I am with the SBP in finding better solutions for Filipinos who have clear lineage to represent the country," Gregorio said. (PNA)

Strong Group-PH beats UAE to complete Jones Cup title sweep

MANILA - Strong Group-Philip-pines defeated United Arab Emirates, 87-62, Sunday, wrapping up the William Jones Cup campaign, with an 8-0 record, at the Xinzhuang Gymnasium in New Taipei City, Taiwan.

Tanjuan Agee finished with 20 points, five rebounds and four assists, while Kiefer Ravena chipped in 13 points, including three triples, to go with nine assists.

DJ Fenner and Ian Miller scored 12 points each, with Dave Ildefonso contributing 10.

The win sealed a historic feat, making Strong Group the first Philippine team to win back-to-back titles in the tournament's 44-year history.

The Philippines now boasts eight Jones Cup titles, joining previous champions Northern Cement (1982), San Miguel (1985), the Centennial Team (1998), Gilas Pilipinas (2012), Mighty Sports (2016, 2019), and Strong Group (2024).

Coach Charles Tiu praised the team's chemistry and dedication.

"We are happy to win a championship again. We never take anything for granted. Our bosses go all out every time to win and to support our teams whenever we represent the country," he said.

The Filipinos extended their un-



beaten run to 16 games across the 2024 and 2025 editions. This year, they beat Chinese-Taipei Blue (67-56), Japan Developmental (79-67), Qatar (81-54), Australia's NBL1 Rising Stars (91-75), Chinese-Taipei White (107-75), Malaysia (106-98), and Bahrain (92-68).

Other members of the champion squad are Jason Brickman, Geo Chiu, Javi Gomez de Liaño, Rhenz Abando, Angelo Kouame and former NBA standout Anthony Roberson.

"It's special, especially because I don't know if we will be able to have this group again. DJ and Brickman are probably joining the draft, Javi and Rhenz will probably have different teams already, and we don't know where our other guys will be next year," Tiu shared.

He also hinted at organizing a Manila-based international invitational to build on their momentum. (PNA)
