MANILA - Several senators formally took on new committee chairmanships on Monday as part of a reorganization of Senate leadership roles in the ongoing 20th Congress.

# NICA, PRIVATE SPONSOR BRING AID TO MARIKINA TYPHOON VICTIMS



MANILA — One hundred families affected by recent typhoons in Barangay Malanday received assistance on Friday through a "Hatid Tulong" outreach program led by the National Intelligence Coordinating Agency — National Capital Region (NICA-NCRO) and a private sponsor.

The relief effort, held at the Bulelak Covered Court, was organized to provide immediate support to residents impacted by Typhoons Crising, Dante, and Emong and to strengthen collaboration between government and private entities.

Alastaire Tereso I. Balitaan, NICA-NCRO Deputy Regional Director, said the initiative is aligned with the national government's priorities.

"President Ferdinand R. Marcos Jr. underscored climate change mitigation as a national priority during his State of the Nation Address," Balitaan said, connecting the relief mission to the broader challenge of climate resilience.

The program was conducted as part of NICA's 76th-anniversary celebration, under the leadership of Director General Ricardo De Leon.

Barangay Kagawad Ferdie Felipe welcomed the assistance, underscoring the local government's commitment to its constituents. He extended his gratitude to the program's sponsor, the Young Siblings group.

Justyne Young, representing the Young Siblings, acknowledged the severe impact of the typhoons on the community.

"Although our contribution may be modest, we are committed to extending support to affected residents as part of our civic responsibility and solidarity with the victims," Young said.

Local officials, including Kagawad Rodel Bayhon, also expressed gratitude to NICA and the Young Siblings for their role in uplifting the community's welfare.

During a ceremonial distribution, representatives from NICA, the Young Siblings, and the local barangay handed over relief goods to the beneficiary families, marking a successful collaboration to bring timely aid to those in need. (JCO/PIA-NCR)

# More repatriated victims forced to work illegally abroad rescued by PH government —BI

PASAY, Philippines— The Bureau of Immigration (BI) reported the return of 14 Filipinos rescued after being forced to work in scam hubs abroad.

BI Commissioner Joel Anthony Viado expressed concern on the growing number of repatriates that allegedly left the country via an illegal migration corri-

dor, or what is more commonly known was backdoor.

The BI's immigration protection and border enforcement section (I-PROBES) reported the arrival of 8 Filipino repatriates from Kuala Lumpur, Malaysia last July 30 at the Ninoy Aquino International Airport (NAIA) Terminal 1. The victims recounted how they were promised work in Laos as office staff, and was offered a salary of P50,000 a month.

The victims stated that they took a boat from Dipolog to Zamboanga, then later transferred to another boat to Malaysia. Upon arrival in Malaysia, they allegedly took a train to Perlis, which borders Malaysia and Thailand, where they were detained by authorities for almost 6 months.

They were eventually able to seek help from the Philippine Embassy in Malaysia, which facilitated their repatriation.

Verification of the BI's forensic documents laboratory showed that their passports contained counterfeit Philippine immigration stamps.

On the same day, another 6 Filipinos arrived at the NAIA Terminal 1 after being repatriated from Phnom Penh, Cambodia.

Out of the 6, only 2 left via NAIA while 4 left on board small boats to reach Cambodia, where they were offered work as customer service representatives, with a promised salary of 1,000 USD



per month.

They ended up working as scammers, and were physically abused when unable to reach their quota. They were assisted by the Philippine Embassy in Cambodia, which facilitated their safe return to the Philippines.

"It is heartbreaking to report that one of the victims, who is pregnant, was subjected to torture whenever she experienced pregnancy sickness," said Viado. "Another victim, a man, was physically struck on the neck for failing to meet his assigned quotas," he added.

Viado expressed his dismay at the continued attempt of Filipinos to depart through illegal means, then end up in abysmal conditions.

"Being forced into illicit activities abroad under threat and abuse is a devastating reality for many," said Viado. "By rejecting illegal methods, we can help break the cycle of trafficking and exploitation. The public is urged to reject such offers and turn only to legal channels for assistance," he added.

Following immigration processing, officials from the Overseas Workers Welfare Administration (OWWA), the Department of Migrant Workers (DMW), and the Department of Foreign Affairs (DFA) worked together to provide immediate assistance to all victims. (BI)

# PH, US STAGE JOINT AID AIRLIFT DRILL IN CLARK

MANILA – The Armed Forces of the Philippines (AFP) and the United States (US) military have successfully conducted a joint simulation exercise at Clark Air Base to demonstrate the rapid airlift of relief goods for communities affected by recent floods.

The activity, held last Saturday, involved the loading and transport of family food packs (FFPs) from the Department of Social Welfare and Development (DSWD) using the US MV-22 Osprey aircraft—highlighting the importance of interoperability, swift logistics coordination, and disaster response readiness.

Defense Secretary Gilberto Teodoro Jr., AFP Chief of Staff Gen. Romeo Brawner Jr., and US Ambassador MaryKay Carlson led the observation of the drill, which also included a guided tour of the Osprey aircraft to showcase its capabilities for quick deployment in humanitarian assistance and disaster relief (HADR) missions.

Carlson reaffirmed support from the United States Indo-Pacific Command (USINDOPACOM), which has been assisting the AFP in delivering aid to areas impacted by successive monsoons.

To date, 4,800 DSWD food packs have been transported and prepositioned, including deliveries to remote areas such as the Batanes Islands.

Teodoro underscored the shared values anchoring the Philippine–US alliance.

"Our partnership is premised on a funda-




mental value, the irreplaceable worth we place on every human life. That is very valuable to both of us. We respect each other, we respect human lives, and we are here to preserve that fundamental value," Teodoro was quoted as saying in a Department of National Defense press release Saturday.

"To our treaty partners, the United States of America, we say thank you. And this will not be the last time. In the spirit of multilateralism, in the spirit of our bilateral people-to-people ties, we hope this partnership will be sustained and enhanced to contribute to the greater good of humankind."

The joint drill forms part of continuing efforts to enhance HADR operations between the two countries under their longstanding security and humanitarian partnership. (With Priam Nepomuceno/PNA)

# PCG CONDUCTS MDA PATROL TO MONITOR AND CHALLENGE CHINESE RESEARCH VESSEL



In a recent initiative to safeguard the nation's maritime interests, Admiral Ronnie Gil Gavan, Commandant of the Philippine Coast Guard (PCG), has ordered the deployment of a PCG aircraft to conduct a Maritime Domain Awareness (MDA) patrol yesterday. This action comes in response to the monitored presence of the Chinese Research Vessel, Xiang Yang Hong 05, which was tracked approximately 37 nautical miles off the coast of Sta. Ana, Cagayan.

The PCG aircraft successfully conducted its MDA flight yesterday afternoon and physically sighted the Xiang Yang Hong 05 at a distance of 14.92 nautical miles from Babuyan Island. The vessel was challenged by the PCG aircraft but did not respond. Notably, the Xiang Yang Hong 05 had previously departed from Guangdong province, China, on June 5, 2025, en route to the West Philippine Sea. It entered the Philippine Exclusive Economic Zone on June 7, approximately 130 nautical miles from Burgos, Ilocos Norte, and subsequently left on June 9, only to re-enter the EEZ last July 31.

Based on its historical track, the Xiang Yang Hong 05 conducted substantial marine scientific research for almost 22 days after departing the Philippine EEZ and before re-entering. This research occurred along a parallel track in the Pacific Ocean, close to Guam at a distance of 216 nautical miles. As of this morning, the vessel was monitored via Automatic Identification System (AIS) approximately 86 nautical miles from Calayan Island, Cagayan.

The Xiang Yang Hong 05, a relatively new addition to China's fleet of research vessels, has been converted from a cargo ship, raising concerns among neighboring countries due to its operations within sensitive maritime zones. Historically, the Xiang Yang Hong series has been associated with supporting the People's Liberation Army Navy (PLAN) operations, dating back to the original vessels that participated in distant-water research and ballistic missile trials during the 1970s and 1980s.

The Philippine Coast Guard remains committed to monitoring and protecting the nation's maritime jurisdiction, ensuring the safety and security of its waters against foreign vessels engaged in unauthorized and illegal maritime activities. (PIA)

# DA pushes for higher rice import tariff, halt on rice imports

MANILA – The Department of Agriculture (DA) is pushing for the temporary suspension of rice importation and an increase in tariffs on imported rice, Presidential Communications Office (PCO) Secretary Dave Gomez said Monday.

Last week, the DA said it is pushing for a modest increase in tariffs on imported rice to at least 25 percent from the current 15 percent.

"The Department of Agriculture is recommending an increase in tariffs on imported rice and a temporary halt to importation to protect local farmers," Gomez said.

The Cabinet would discuss the matter with President Ferdinand

The DA measure is part of the Marcos administration's target to gradually revert to the original 35 percent tariff on imported rice, a year after the implementation of reduced duties to help lower soaring retail rice prices. (PNA)

# Pag-IBIG Fund reports record P28B net income in first half of 2025

MANILA, (PIA) — The Home Development Mutual Fund posted its highest six-month earnings in 45 years, with net income surging 15% to P28.04 billion in the first half of 2025, officials announced Friday.

The government housing finance agency, known as Pag-IBIG Fund,

saw gross income rise 12% to P44.39 billion from January through June compared with the same period last year.

The performance marks the strongest earnings period since the agency's establishment in 1980, driven by increased collections and higher returns from housing and short-term loan portfolios.

# Investment returns drive growth

Investment income jumped 52% year-over-year to P4.27 billion, accounting for nearly 6% of total gross income. The gains came from strategic investments in bonds, debt securities, money market instruments, equities and investment properties.

"This performance shows how excellently we are managing the funds that our members have entrusted to us," said Human Settlements and Urban Development Secretary Jose Ramon Aliling, who chairs the agency's 11-member board of trustees.

The strong financial position sup-



ports the government's Expanded Pambansang Pabahay para sa Pilipino housing program, aimed at providing more Filipinos access to home ownership, Aliling said.

# Assets reach P1.14 trillion

Total assets grew 7% to P1.14 trillion as of June, an increase of P74.90 billion from year-end 2024.

Pag-IBIG Fund Chief Executive Officer Marilene Acosta emphasized that the agency's charter requires returning at least 70% of annual net income to members as dividends credited to their savings accounts.

"Pag-IBIG Fund is owned by its members — the Filipino workers. It is our duty to grow and protect their savings," Acosta said. The agency serves millions of Filipino workers through savings programs and affordable home financing.

The record earnings position the fund to expand housing assistance while maintaining competitive returns for member savings, officials said. (JCO/PIA-NCR)

# Gov't advances plan to protect indigenous peoples and ancestral domains

The government has begun developing a National Action Plan on Business and Human Rights (NAPBHR), with a strong focus on protecting indigenous peoples (IPs) and their ancestral domains.

The initiative supports President Ferdinand R. Marcos Jr.'s commitment to human rights and inclusive development, as highlighted in his 2025 State of the Nation Address.

Held on July 15 in Makati City, the first workshop brought together over 50 representatives from 25 government agencies involved in indigenous rights, business regulation, and sustainable development.

With the theme, "Toward a Philippine National Action Plan on Business and Human Rights: Strengthening Protection for Indigenous Peoples and Ancestral Domains," the event was led by the Presidential Human Rights Committee Secretariat (PHRCS) in partnership with the National Commission on Indigenous Peoples (NCIP), civil society groups, and supported by the European Union Delegation to the Philippines through the Land Justice Initiative.

PHRCS Executive Director Undersecretary Severo Catura underscored the importance of justice, unity, and respect for IPs in shaping national policies.



Judge Jesus Torres, former head of the Commission on Human Rights Economic, Social, and Cultural Rights Center, highlighted international frameworks like the UN Guiding Principles on Business and Human Rights, outlining the state's duty to protect, the responsibility of businesses to respect rights, and the right of individuals to access remedies.

Legal and policy expert Atty. Reina Bermudez also discussed the Philippines' legacy and policy landscape on BHR, as well as sound governance principles.

A second workshop is set to gather input from Indigenous communities, civil society, and the private sector.

A technical working group led by the NCIP, will then draft a preliminary version of the plan for further review.

The NAP-BHR is part of the Philippine Human Rights Plan 2024–2028, which aims to safeguard Indigenous rights and cultural heritage amid expanding business activities. (PND)

The Court finds the motion meritorious.

Section 16, Rule 14 of the 2019 Amended Rules of Court allows the service of summons by publication upon a defendant whose identity or whereabouts are unknown, to wit:

Section 16. Service upon defendant whose identity or whereabouts are unknown. — In any action where the defendant is designated as an unknown owner, or the like, or whenever his or her whereabouts are unknown and cannot be ascertained by diligent inquiry, within ninety (90) calendar days from the commencement of the action, service may, by leave of court, be effected upon him or her by publication in a newspaper of general circulation and in such places and for such time as the court may order.

Any order granting such leave shall specify a reasonable time, which shall not be less than sixty (60) calendar days after notice, within which the defendant must answer.







# Maynilad cuts water losses to 36.2%, recovers 970 MLD since 2006

West Zone concessionaire Maynilad Water Services, Inc. (Maynilad) has reduced its non-revenue water (NRW) level to 36.2% as of Q1 2025, a significant improvement from 66.4% in 2006—the year the company was re-privatized.

This achievement translates to the recovery of 970 MLD—enough to meet the daily needs of millions of residents in the West Zone—through sustained investments and operational improvements over nearly two decades.

Maynilad inherited one of the oldest and most leak-prone pipeline systems from the Metropolitan Waterworks and Sewerage System (MWSS). Its NRW reduction was achieved despite these challenging network conditions, requiring extensive technical interventions and capital expenditures

Maynilad's NRW Management Program includes the creation of District Metered Ar-

eas (DMAs), advanced network diagnostics, active leak detection and repair, massive pipe replacement projects, and strict meter management. As of Q1 2025, Maynilad has replaced 3,293 kilometers of aging pipelines and repaired over 18,000 pipe leaks in just the first quarter of the year.

"Reducing water losses in a highly complex and aged network like ours requires long-term investment and continuous innovation. This milestone underscores our commitment to enhancing operation-

al efficiency and achieving our NRW targets," said Maynilad Central NRW Head Engr. Ryan Jamora.

According to its IPO Prospectus, Maynilad aims to further reduce NRW to 25% by 2027 and 20% by 2030, maintaining this level until the end of the concession period.

Maynilad is the largest private water concessionaire of Metropolitan Waterworks and Sewerage System (MWSS) in the Philippines in terms of customer base. Its service area includes the cities

of Manila (all but portions of San Andres and Sta. Ana), Quezon City (west of San Juan River, West Avenue, EDSA, Congressional, Mindanao Avenue, the northern part starting from the Districts of Holy Spirit and Batasan Hills), Makati (west of South Super Highway), Caloocan, Pasay, Parañague, Las Piñas, Muntinlupa, Valenzuela, Navotas, and Malabon, all in Metro Manila; and the cities of Cavite, Bacoor, and Imus, and the municipalities of Kawit, Noveleta, and Rosario, all in the province of Cavite. # PALACE CONGRATULATES BOC FOR SURPASSING TARGET WITH P84.5 B JULY REVENUE

Malacañang has commended the Bureau of Customs (BOC) for surpassing its Development Budget Coordination Committee (DBCC) revenue target by 100.2 percent for July 2025.

In a Palace press briefing on Friday, Presidential Communications Office Undersecretary and Palace Press Officer Claire Castro said BOC collected PhP84.5 billion in July, surpassing its revenue target of PhP84.4 billion by PhP140 million.

BOC's July performance marked its highest monthly collection this year and reinforced President Ferdinand R. Marcos' administration's commitment to sound fiscal governance.

Castro said the BOC's July collection also represented a significant increase from the PhP77 billion collected in June and the PhP80.4 billion posted in July 2024.

# **COMPASSIONATELY SERIOUS**

Exodus 6:9-11 9 Moses spoke thus to the people of Israel, but they did not listen to Moses, because of their broken spirit and harsh slavery. 10 So the Lord said to Moses, 11 "Go in, tell Pharaoh king of Egypt to let the people of Israel go out of his land."

Whenever we face typhoons, we are reminded that we not only face personal problems but the world is not on our side. Because of this, we sometimes think that God allows evil things to happen and he has no plans of really helping us.

The Israelites faced a similar situation wherein instead of deliverance as they requested, they received more afflictions.

In the previous verses God promised nine "I wills". But Israel's response was they will not listen (v9). God had already revealed who He is and confirmed that He is the God of their fathers by declaring His sworn promise. Yet Israel still responded with, "they did not listen to Moses, because of their broken spirit and harsh slavery."

Faced with difficulty, they find it difficult to trust God. The problem is, their understanding of God is based on the idols they were acquainted with in Egypt. If they knew YHWH intimately, they will hope in God's unwavering will. Their ignorance distorts their view of God because they were focused on other things than God.

And this is similar to us. It's important that we know the God we serve by studying His Word. If you neglect the study of His Word, do not be surprised when you slowly drift away from Him. One reason is that you are more concerned with other things than God.

Indeed, it's difficult to worship the Lord with a broken spirit. Many of us even choose not to attend church when we're going through something heavy. Some set church activities aside because of the burden they carry, as though the church gets in the way of their solution. However, is it the right response to draw farther away from Him who knows everything, who understands what we are going through, and who values our suffering? He is the almighty God who created the heavens and the earth. He is the good God who saved us. Is it right to disregard Him? Did Christ die for us only to be treated as though He doesn't matter?

This downheartedness of Israel did not shake God's plan. He was not disappointed nor discouraged to continue, rather He ordered Moses to demand Pharaoh for Israel's release (v10-v11). From three days journey to a full release from his hold. It was not because God suddenly decided differently, but to make clear what God had planned from the beginning (Exodus 3:10, Genesis 15:13-16).

The unchanging mind of God shows that He is compassionately serious and He can be relied on.

At times, we are like a child who doubts our father's decision for us. We think they do not understand us but in reality, they've been there and wants nothing but the best for us. Of course, not all earthly fathers are like that. # PH ARMY PROBES ROOKIE SOLDIER'S DEATH DURING RECEPTION RITES

MANILA – The Philippine Army (PA) is investigating the death of a rookie soldier, supposedly during reception rites at his unit in Maguindanao del Norte last week, an official said Monday.

In a message to reporters, PA spokesperson Col. Louie Dema-ala said two officers and 19 enlisted personnel have been relieved amid the ongoing investigation.

According to reports, Pvt. Charlie Patigayon, 22, was undergoing reception rites with other soldiers at the 6th Infantry Battalion headquarters in Barangay Capiton, Datu Odin Sinsuat when he collapsed on July 30.

Patigayon, a native of Kolambugan, Lanao del Norte, died the following day.

Reception rites are a series of exercises new soldiers are instructed to do when reporting to their units.

"We assure Pvt. Patigayon's family that the PA is committed to pursuing justice," Dema-ala said in a statement.

"Should the investigation confirm wrongdoing, those responsi-



ble will be held fully accountable under the military justice system and all applicable laws."

Dema-ala stressed that in compliance with the Anti-Hazing Act of 2018, the PA "upholds a zero-tolerance policy against any practices that endanger the safety and well-being of its personnel."

Aside from pursuing justice, Dema-ala said the PA is also providing all the necessary assistance and support to Patigayon's family.

"While no form of compensation can ever replace the life of a soldier, we are committed to honoring Pvt. Patigayon's service and to (ease) the burden on his loved ones," he said. (PNA)

# **World Games 2025 Athletes Village open**

MANILA – More than 4,000 athletes from 114 countries competing across 34 sports and 60 disciplines will stay in the 2025 World Games Athletes Village, which was opened Sunday, four days ahead of the multi-sport event to be held on Aug. 7-17 in Chengdu, China.

The state-of-theart Village, Zones A and B, has comprehensive support services, including medical and chiropractic centers, dining halls offering diverse food, training and recreation zones, laundry facility, and multi-language assistance hubs.

Athletes, coaches, and International Federation (IF) officials from air sports, American football, billiards. boules sports, canoe, cheerleading, fistball, flying disc (Ultimate), gymnastics, handball, jiu-jitsu, karate, korfball, lacrosse, lifesaving, orienteering, powerboating, sambo, sport climbing, triathlon, tug of war, underwater sports, waterski and wakeboard will stay in Village A.

Village B will accommodate athletes and staff from archery, baseball-softball, dancesport, floorball, flying disc (disc golf), kickboxing, muaythai, powerlifting, racquet-ball roller sports

squash and wushu.

National Olympic Committee (NOC) and National Sports Organization (NSO) delegations will also stay in Village A.

Meanwhile, the IWGA Family, including guests and key international stakeholders, will reside at the Intercontinental Century City Hotel —the assigned headquarters hotel in Village B.

"This Village represents the starting point of dreams fulfilled, personal bests achieved, unforgettable and moments shared. It is here that athletes will rest, recover, and build bonds that go beyond borders, beyond language, and beyond competition," International World Games Association (IWGA) chief executive officer Joachim Gossow said in a press statement on the World Games website Monday.

"The Villages —both A and B— are more than just buildings to accommodate our athletes and teams. They are the very heart of The World Games. I want to express my deepest appreciation to the Local Organizing Committee. Your dedication, precision, and vision have set a new benchmark for athletes' accommodation at The World Games.

From thoughtful layout and modern facilities to world-class services —every detail reflects a deep respect for the athletes and for the values of our Games," he added.

The Philippines is sending 47 athletes, led by Agatha Wong (wushu), Raphael Trinidad (skateboard), Rubilen Amit (billiards) and Annie Ramirez (jiu-jitsu), to the World Games featuring sports not on the Olympic program.

Wong, a two-time World Championships silver medalist and five-time Southeast Asian Games titlist, and Trinidad, champion in the IWWF Asia and Oceania Championships, will carry the Philippine flag during the parade of athletes in the opening ceremony on Aug. 7 at the Tianfu International Convention Center.

Muaythai Association of the Philippines president Stephen Arapoc is the Team Philippines chef de mission.

Also attending the World Games are Philippine Olympic Committee (POC) president Abraham "Bambol" Tolentino and secretary general Wharton Chan, and Philippine Sports Commission chairman John Patrick Gregorio.

# **NU spikers unbeatable in Shakey's Super League Mindanao leg**

MANILA - National University remains unsinkable despite the departure of key players

Minus three-time UAAP MVP Bella Belen, Alyssa Solomon, Sheena Toring and Erin Pangilinan who helped the team defend the UAAP title this year, the Lady Bulldogs managed to rule the Mindanao leg of the 2025 Shakey's Super League (SSL) National Invitationals Sunday night.

Banking on veteran Arah Panique, skipper Evangeline Alinsug, setter Camille Victoria Lamina and rookie sensation Samantha Cantada, NU pulled off a 25-21, 20-25, 25-20, 25-17 win over a University of the Philippines to sweep the three-day event at the University of Southeastern Philippines Gym in Davao City.

"This is our first league as a rebuilding team. We are very happy because we got it. We know that many people thought that we were going to fall, but now we have witnessed that we can handle it even though our seniors are gone," said Alinsug, who scored 13 points.

Panique led the Lady Bulldogs with 25 points off 21 attacks, two aces and two blocks while Cantada, the 2025 Shakey's Girls Invitational Volleyball League MVP, chipped in 16 points anchored on 11 attacks and five service winners.

Lamina made 23 excellent sets for NU, which had 61 attacks, nine aces and 10 blocks. NU beat Notre Dame of Dadiangas University (25-19, 25-13, 25-19) and host Davao Selection (25-9, 25-12, 25-14) while UP prevailed over Davao Selection (25-11, 25-13, 25-15) and NDDU (25-19, 25-13, 25-19).

"I think UP is a team to beat in the UAAP. The battle is there and I think it will be a big morale-booster for us when it comes to the UAAP," said NU head coach Sherwin Meneses, who arrived Sunday morning in Davao City. His assistant, Alvin Dumalaog, took over in the first two games.

"Those who are left behind, the system is already there. Of course, the main goal is the UAAP. We lost four seniors so we will start again. We are looking for experience in the new team then focus on training and hopefully, no injuries."

Meanwhile, the Visayas leg is scheduled from Aug. 22 to 24 in Cebu City. Batangas will host the Luzon leg. (PNA)
